2.3 Pool Competition Calendar 2024

Richard Hughes as Chair of the Pool Competition Committee thanked clubs for providing the EOI form for 2024 events. From the EOI's the calendar for 2024 will be a repeat of 2023 and clubs have requested the same events around the same times.

RH also commented that clubs should be looking to host small invitational events for other clubs to participate in social events to engage the newer swimmer. 3.2 Operations Update

Sadly, the organisation will be losing Hannah Lawton. Hannah successfully secured a position with Sport West in the role of Event Manager. This is a great opportunity for Hannah but a great loss for MSWA.

Sue Gliddon will be moving to Masters Swimming Australia as the National Governance Specialist with the role based in WA. As such, there will be a continued relationship and a thorough hand over to the incoming EO.

Question from the floor: Will K Preston be replaced.

This was addressed by the Chair of the MSWA Coaching Committee, Siobhan Wilkins.

SW advised that Couch to 2K programs continued to be delivered but were being undertaken by coaches local to facility clubs. This has created cross over to membership for clubs.

For other programs, a pool of coaches has been developed.

Programs will be run under the "Swim West" banner, a newly registered business name by MSWA. This is to attract a younger audience required to maintain 2024 funding by Healthway.

President of Rockingham Club asked SG about the availability of the Member insurance policy with MSA. SG advised she will again take this up with MSA and appreciated the need for club committees to understand the contents of the policy.
