3 Items for Discussion

3.1 DLGSC funding update

- The DLGSC grant is an Industry Investment Program grant worth \$70k per year for 3 years. This represents approximately 28% of our revenue.
- The WA State Government policy is to now fund only the pre-eminent organisation in each sport. As such, the funds are to be passed through Swimming WA to MSWA. The DLGSC has confirmed that 100% of the funds are to be passed through from Swimming WA to MSWA. The Board has informed DLGSC that we will accept the funding through SWA as this decision was required in March 2025.
- The next steps will be for MSWA and SWA to develop a service agreement prior to July/ Aug IIP KRS agreement being developed with DLGSC. There is some risk that the SLA might not be agreed between the two parties.
- The MSWA Board will oversee the negotiations and agreement to ensure MSWA best interests are served.
- The fall back position if the funding is lost is for the EO to drop down to 4 days per week and for the C&E position to become a volunteer position. This was the situation some years ago. It should be noted that the time spent managing the grant by the EO is not insignificant and would be removed if this were to occur.

4 Items for Information

4.1 Office Relocation

The office will relocate on the 4^{th} of July to the Royal Life Building which is next to the 10 Lane pool at the Perth High Performance Centre. A benefit is that rent will be reduced from \$9K per year to \$5K per year. This also avoided a rent increase of \$6K per year if the office stayed at the current premises.
