1.4 Board & Committee reports

2 Items for Discussion

2.1 ATO reporting for NFT's (sporting clubs) update and Q&A

Rhys King and Andre Meyer the Finance Manager from SWA, Accountant and Westcoast Masters member provided an overview of the new ATO requirements for NFP. Attendees were provided

As part of the new ATO requirements NFP with an active ABN will need to lodge a return that confirms their NFP status. This will be applicable for clubs.

The first challenge is getting access top the ATO and determining who your tax Associate is then setting them up on the clubs mygovid and RAMs platform. Rhys King will also send the change of details form to clubs with minutes. It is recommended to complete the form rather that call if clubs are unsure of who their Associate is.

Once this is done the lodgement is apparently fairly straight forward with only potential hurdle being that your constitution is up to date stating it objects and distribution of funds.

2.2 Mental health initiative
